Step 4 – DREAM AGREEMENT

RECIPIENT OR GUARDIAN MUST INITIAL EACH PARAGRAPH

1. **Granting of Dream.** Woody's Dare to Dream Foundation ("WDDF") agrees to pursue the fulfillment of the Dream of the person named above ("Recipient") in accordance with the term san conditions of this agreement. WDDF reserves the right in it is sole discretion to decide if a dream will be granted. _____
2. **Permission to disclose any personal information.** The Recipient grants the WDDF the right to disclose any person information to the extent necessary in the fulfillment of the Dream. _____
3. **Relatives/Friends.** No person may accompany the Recipient during any portion of the Dream fulfillment, unless specifically agreed to in writing between WDDF and the Recipient. _____
4. **Waiver.** The Recipient hereby waives and all rights he or she may have or may have hereafter acquire against WDDF, its officers, directors, agents, employees arising out of any injury, damages, or losses suffered by the Recipient, family friends or each and any of them, arising out of or in any way related to WDDF preparation, execution or fulfillment of the Dream, regardless of whether such loss or harm is caused by the active, passive or gross negligence of WDDF or any other person. _____
5. **Release.** Recipient, relatives or friends, together, and each of them individually, does hereby forever release and remise WDDF, its officers, directors, agents, and employees from any and all claims, lawsuits, damages, or losses arising out of or in any way related to Woody's Dare to Dream Foundation preparation, execution or fulfillment of the Dream, any suffered by Recipient, relatives or friends, or any of them of whatever nature, and of whatever extent, regardless of whether such loss or damage is caused by the active, passive or gross negligence of WDDF or any other person. _____
6. **Indemnity.** Recipient, relatives or friends, together and each of them individually, hereby agree to indemnify and hold harmless WDDF, its officers, directors, agents, and employees of and from any and all losses suffered by WDDF, its officers, directors, agents, and employees as the result of any claim, lawsuit, or action arising out of or relating in any manner to WDDF's preparation, execution and fulfillment of the Dream, or to breach by Recipient, relatives or friends of the representations and warranties contained in paragraph 6 of this agreement. Said hold harmless and indemnity includes, but is not limited to, reasonable attorneys fees and costs incurred by WDDF, it officers, directors, agents, and employees in retaining attorneys of WDDF's choice to defend any and all such claims, lawsuits, and actions. _____

7. Termination of dream. Woody's Dare to Dream Foundation reserves the right, in its sole and absolute discretion, to abort preparation or fulfillment of the Dream at any time after the signing of this Agreement, if WDDF should determine that:

- (a) fulfillment of the Dream will endanger the health and safety of Recipient or of others,
- (b) the Recipient is or will be incapable of appreciating or utilizing the goods, services, or activities related to the Dream, or
- (c) events or circumstances render it impractical, imprudent, or inadvisable to fulfill or continue to fulfill the Dream of this Agreement.

In the event WDDF aborts preparation, or fulfillment of the Dream, Recipient, relatives and friends agree that WDDF shall not be held liable or responsible for any expenses that Recipient, relatives and friends may have incurred in contemplation of WDDF's fulfilling the Dream. NOTE: Only Woody's Dare to Dream Foundation may make a request for resources on behalf of a dream. If the dream Recipient, family members, friends or anyone having knowledge of this dream uses the name of Woody's Dare to Dream Foundation to solicit support, the Dream will be immediately disqualified and terminated. _____

8. **Further Assurances.** Recipient, relatives and friends agree that he or she shall, at the request of WDDF, execute and deliver to WDDF all further documents that WDDF deems necessary or appropriate in order to prepare, execute and fulfill the Dream. _____

9. **Counterparts.** This Agreement may be executed in counterparts, any of which shall be deemed to be an original. _____

10. **Amendment.** This Agreement shall not be modified or superseded, except by a writing executed by the parties. _____

11. **Governing law.** The laws of British Columbia and Canada that Woody's Dare to Dream Foundation is based shall govern this Agreement. _____

12. **Binding effect.** This Agreement is binding on all heirs, successors, representatives, and assigns of all parties hereto. _____

13. **Severability.** If any portion of this Agreement shall be determined to be invalid or unenforceable, all other portions shall remain valid and enforceable. _____

14. **Entire agreement.** This Agreement constitutes the entire Agreement and understanding of the parties with respect to the transaction contemplated hereby, and supersedes all prior agreements, arrangements and understandings related to

the subject matter. No representation, promise, inducement or statement of intention has been made by any of the parties hereto not embodied in this Agreement and no party shall be bound by or liable for any alleged representation, promise, inducement or statements of intention not set forth or referred to herein.

15. **Captions.** The Captions appearing in this Agreement are for convenience and ease of reference only. They in no way describe, limit or extend this Agreement or any of its provisions. _____
